- 1) GPA (Note – In prior years, an official transcript was required as proof of academic performance. Recognizing there may be logistical challenges involved with obtaining an official transcript this year, you may submit any sufficient evidence such as report card showing cumulative GPA, unofficial academic records, etc.)
- 2) Extracurricular activities
- 3) Written essay
- 4) Interview
