Kroc Center Tour

On September 30th, Hawaiian Dredging took CFMA members on a tour of the Salvation Army Ray & Joan Kroc Corps Community Center. Located on 15 acres of land in Kapolei, the 200,000 square-foot Kroc Center will be the largest community center of its kind in Hawaii when completed in the fall of 2011.

During the tour, CFMA members got a first-hand look at the Kroc Center's Harry & Jeanette Weinberg Education & Resource Center with conference and



banquet rooms for 720 guests; Mary D. and Walter F. Frear Early Education Center for 150 preschool students; 500-seat Jack & Marie Lord Worship & Performing Arts Center; Clarence T.C. Ching Athletic Center with an NCAA-regulation gymnasium; First Hawaiian Bank Hale Hookipa 48-bed dormi-

tory for traveling teams and overnight conferences; state-of-the-art Health & Wellness Center with workout equipment and facilities for individual and group fitness; an Aquatics Center featuring a competition pool and a recreation pool with giant water slides; and a 3-acre multipurpose field for outdoor programs.

Brown Bag — Human Resources Update

Jeffrey Harris, Director at Torkildson, Katz, Moore, Hetherington & Harris, was the featured speaker at our October 7th Brown Bag meeting held at GPC's Puuhale conference room. Jeff kept his presentation informal and encouraged all the participants to ask questions as they come up. One of the topics Jeff spoke about was on Project Labor Agreements (PLA). Did you know that the rail project is subject to a PLA? Apparently, the language in the PLA was negotiated between the City and the Unions, without the input from the General Contractors Association of Hawaii (GCA). Jeff went on to mention that Governor Abercrombie was considering the idea of having PLAs in local government contracts as well. There has been opposition toward PLAs due to the possible negative effects for non-union contractors entering into PLAs, as well as for local union contractors whose pool of skilled workers could be drained.

The new State sick leave law (Act 118) that went into effect in July of 2011 was also reviewed by Jeff. The law prohibits the termination or demotion of employees who use accrued and available sick leave

for three or more consecutive days without a physician's note. As this is a recently enacted law, there are many issues that need to be resolved (i.e., opinion rendered) before the full extent of the Act is known.

Lastly, Jeff spoke on Whistleblower claims – very scary stuff when you consider that the person making a whistleblower claim only had to have the intent to speak up about a wrong doing on a Federal protected class or contract. Jeff was gracious about leaving time at the end of his presentation to give everyone a chance to "ask a lawyer" about various human resource related topics.

Besides a handout on the above mentioned topics, Jeff passed out a copy of "The 2011-2012 Hawaii Camber Desk Manual, Labor and Employment Law for Hawaii Employers" to all in attendance. CFMA would like to thank Jeffery Harris taking time out from his schedule to share his expertise at this session, and to CFMA member Garrett Sullivan for helping to arrange the presentation.



Mayor Peter Carlisle and Garrett Sullivan were the feature speakers at the December 5, 2011 CFMA Seminar held at the Pacific Club. There were twenty eight members and seven guests present who took this opportunity to network during breakfast. The attendees were briefed on the current state of the City's rail project and learned about the concept of "ownership thinking" in the workplace.

Mayor Carlisle spoke passionately about the City's rail project as it will be the vehicle to provide an alternate means of transportation to and from the west side of Oahu, it will inject millions of dollars into the local economy during its construction phase, and it will become the key in transforming the City (spurring development around the transit stations and creating opportunities for small business growth). As the rail system will be powered by electricity, it will spur the growth of alternative energy source generation (e.g., H-Power, the use of ocean temperature differentials, the use of methane gases in the landfill, etc.). The Mayor stated that there were two key events that oc-



oversee the planning, construction, and operation of the rail system. The Mayor strongly believes the rail project will play a critical role in re-energizing our City during the coming decades.

Garrett Sullivan, President and Founder of Sullivan Associates, Inc., a current CFMA member, informed us about the business concept of "Ownership Thinking". The Ownership Thinking model was developed in the early 1990's by Brad Hams and stresses the elimination of the "entitlement mentality" in the workplace and replaces it by empowering employees to think and act like owners. The four major components of Ownership Thinking are: The Right People, The Right Education, The Right Measures, and The Right Incentives. This program is intended to encompass all employees of the company, from office staff to field workers, non-union as well as union employees.
